# Tips For Choosing an Adaptive Bike

# 1. Measure Inseam

The measurement we use to ensure each rider gets the correct size of adaptive bicycle is called an inseam. To find an inseam, measure the distance between the bottom of the rider's heel to the top of the rider's inner thigh. Make sure the rider's inseam measurement matches the inseam range for the adaptive bicycle.

# 2. Know Your Accessories




